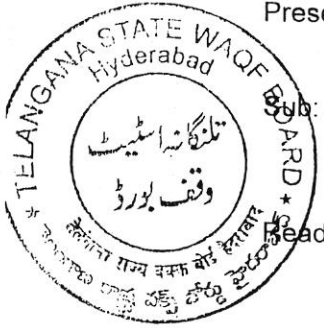

**ORDERS:**

The Institution namely Masjid-e-Mohammedia Situated at Vittalwadi, Narayanguda, Hyderabad is a notified Waqf published in A.P. Gazette No.28-A dated: 19-07-1984 at Page No.4 , SI.No. 1613 to an extent of 363.3 Sq.yds under the control of Telangana State Waqf Board.

In the reference 1<sup>st</sup> read above representation received for Constitution of Managing committee for the subject Institution.

In the reference 2<sup>nd</sup> read above the Inspector Auditor concerned submitted report and recommended to Constitute Managing Committee for the subject Institution.

The matter has been examined and placed before the Competent Authority, T. S. Waqf Board who passed orders for Constitution of the Managing Committee for the subject institution for a period of (2) two years vide reference 3<sup>rd</sup> read above.
