No. 328, measuring 2-07 Acres, Sy, No.592, measuring 1-08 Acres and Sy, No.588, measuring 1-29 Acres situated at Ponkal Village and Sy No.309 and 457, situated at Mamada Village & Mandal is exclusively a service inam land and notified waqf properties. and published in the A.P. Gazette No. 13-A Supplement Part-II, Dated: 30-03-1989 in Sl. No.6595.

In the reference 1<sup>st</sup> read above, it has been informed that the Board has constituted the Managing Committee U/Sec 18 of the Waqf Act, 1995 he requested to this office to constitute the Managing Committee for looking after the affairs and protection of Waqf property.
