### ORDER:

In the reference 1st read above, the Andhra Pradesh State Wakf Board was formed. In the reference 2nd read above the State of Andhra Pradesh has been bifurcated into the State of Andhra Pradesh & State of Telangana with effect an and from 2nd Jun, 2014 i.e., appointed day in terms of Andhra Pradesh Reorganisation Act, 2014.

- 2. Thereafter a proposal was submitted to Government of India by Telangana State proposing bifurcation of the Andhra Pradesh state Wakf Board vide Letter No.108/OP & Budget/A1/2014, M.W.(OP & Budget) Dept, dated; 27-07-2015, in terms of Section 102 of Wakf Act 1995 as amended in 2013.
- 3. In the reference 3<sup>rd</sup> read above, Ministry of Minority Affairs, Government of India, communicated that in exercise of the powers conferred by sub-section (2) to (5) of Section 102 of the Wakf Act, 1995 (Central act 43 of 1995) the Central Government after consulting the central Wakf Council and the State Governments of Andhra Pradesh and Telangana has approved the scheme for dissolution of Andhra Pradesh state of Wakf Board and for reconstitution of Separate Wakf Boards for the respective States of Andhra Pradesh and Telangana and requested to take further necessary action. The above decision is notified in PART-II Section 3 Sub-Section (ii) of Extraordinary issue No.1917 of the Gazetted of India, dated: 08-09-2015.
- 4. In consonance with the Government of India proposals, the Government of Telangana ordered for dissolution of the Andhra Pradesh State Wakf Board and further ordered for establishment of the Telangana State Wakf Board from the appointed day i.e., 8th September, 2015 vide G.O.Ms.No.43, M.W.(OP & Budget) Dept, dated: 19-10-2015.

- 5. Vide G.O.Ms.No.44, M.W.(OP & Budget) Dept, dated: 19-10-2015 a Competent Authority was appointed to exercise the powers of the Board till the Board is constituted.
- 6. The Hon'ble High Court in W.P. 7023 of 2016 in its order dated 12-09-2016 ordered constitution of the Board for Telangana State Wakf Board with a span of three months and subsequently granted one more month time by its order on 24-01-2017. Accordingly, vide G.O.Ms.No.40, M.W.(Estt.I) Dept, dated: 07-12-2016, Government has notified Sri Rahul Bojja, IAS, District Collector, Hyderabad as Election Officer and vide G.O.Ms.No.41, M.W.(Estt.I) Dept, dated: 06-12-2016, the Election schedule was notified for electing the elected members of the Board as per Section 14 (1) (b) of the Wakf Act. The District Collector, Hyderabad and Election Officer vide Certificate of Elections (Form-X), dated: 04-01-2017 informed that Elections were held as per Section 14 (1) b) of Wakf Act, 1995 and informed that the following members in various Categories have been declared Elected as there was only one candidate left after withdrawals in each of the Categories mentioned in u/s.Section 14 (1) (b) from i to iv Categories.

2. Janab Mohammed Saleem 14 (1) (b) ii. : Member of State Legislature
