The Orphanage is under the Direct Control of Telangana State Waqf Board. This Orphanage is supported by various organization by way of conducting Medical Camps, Education tours, and Symposiums.

The Hon'ble Chief Minister announced to give adjacent PWD Office land to an extent of **4000 sq.yards** for developing this institution as a Model Orphanage.
