ORDER:-

Government have constituted Telangana State Waqf Board, Hyderabad vide G.O. 2nd read above, and in exercise of the powers conferred under Sub-Section (9) of Section (14) and Section (15) of the Waqf Act, 1995 (as amended in 2013), the Governor of AP & Telangana State have appointed Members of the Telangana State Waqf Board. The term of the said members of the Waqf Board as notified vide reference 2nd read above, has expired on 22.02.2022 i.e. on completion of five years.

2. In the reference 3rd read above, Government have appointed Sri L.Sharman, I.A.S., Collector & District Magistrate, Hyderabad as Election Officer towards conducting of Election for the categories (i) to (iv) as per the provisions laid down under Section 14 (1) (b) of Waqf Act, 1995. (Amended in 2013) for reconstituting of Telangana State Waqf Board, while notifying the Election schedule for conducting of the Elections to Waqf Board and subsequent election of the members to the Board.

3. In the reference 5th read above, the District Collector Hyderabad & Election Officer, has informed of the completion of the elections for the Categories viz., i, ii, iii & iv as per the provisions laid down under Section 14 (1) (b) of Waqf Act, 1995, and the certificates of election in Form.X, Dated.28.02.2022 were issued to the elected candidates, whose respective particulars category wise are detailed hereunder :-

2. Janab Farooq Hussain 14 (1) (b) (ii) : Member of State Legislature.
