**ORDER:**

In the reference 2<sup>nd</sup> read above, the Hon'ble M.L.A., Warangal East Constituency, Warangal District has submitted certain proposals for sanction of Grant-in-aid for Construction/Repairs/Renovations etc., in Warangal East Constituency.
