ORDER

The Waqf institution namely Masjid-e-Asar-e-Shareef (Rahmania) and Graveyard situated at Tallagadda, Hyderabad is a Waqf institution published in A.P Gazette No. 11 dated 23-03-1978 with an extent of 4020 Sq Yds attached land under control of State Waqf Board.

A Managing Committee was constituted in the ref 1st read above for a period of two (2) year under the Presidentship of Janab Mahmood Mohiuddin which expired on 28-11-2014.

In the ref 2nd read above, this office issued an Office Order to the Waqf officials directing to take the subject Waqf institution under Direct Management of the Telangana State Waqf Board.

In the ref 3rd read above, Janab Md Shafiuddin, President Managing Committee submitted a representation stating that the committee is discharging its legitimate duties and stated that Janab Mohmood Mohiuddin, the than President of the Managing Committee has shifted his resident from the jurisdiction of this Masjid area, as such his services has been terminated. Further he has submitted a panel consisting of the seven (7) members and requested to extend the term of the Managing Committee.

In the ref 4th read above, Janab Kausar Mohiuddin, Hon'ble M.L.A submitted a representation stating that the present Managing Committee of Masjid Asar-e-Shareef (Rahmania), Tallagada, Karwan, Hyderabad is discharging its obligations and responsibilities with honesty, transparency and accuracy. Further it was informed that the said Managing Committee is also contesting cases efficiently and recommended to extend the term of the Managing Committee.

The matter was examined in detail and Competent Authority, Telangana State Waqf Board in the ref 5th cited, ordered to extend the term of the Managing Committee.

In pursuance to the above orders, a Managing Committee consisting of the following members is hereby constituted for a period of two (2) years from the date of the receipt of the date of issue of this proceedings under the presidentship of Janab Md Shafiuddin U/s 18 of the Waqf Act 1995 read with Andhra Pradesh Waqfs Managing Committee (Constitution, Functions and Duties) Regulations 2009 with the following office bearers and members.
